2 Year Old Program - \$1,125 for 9 r	months/\$125 monthly.
3 Year Old Program - \$3,700 for 10	months/\$370 monthly.
4 Year Old Program - Morning - \$4	.750 for 10 months/\$475 monthly.

Monthly Tuition Payments - The first monthly tuition payment is due on August 2, 2024 for the 3 and 4 Year Old Programs and September 2, 2024 for the 2 Year Old Program. Tuition payments must be processed by credit card. Cash or check tuition payments are not accepted.

Credit Card Tuition Payment - Please contact the Director of the Village Nursery School if you have any questions about this policy.

Required Authorization for Recurring Credit Card Transaction Form - The Credit Card form must be completed to register your child. Your credit card will be charged for the New Family Registration Fee, if applicable, and the Tuition Deposit at the time of registration. Monthly tuition will be charged according to the Monthly Payment Schedule. You will receive a copy of your invoice by email.

Absences/School Closures - Monthly tuition is due in full each month, regardless of absences or school closures. In case of extended absences, tuition must be kept current to keep the student enrolled.

Delinquent Accounts - You will be contacted promptly if your credit card is declined. Tuition not paid in full by the 10th of the month will be assessed a \$25.00 late payment fee, per month. Invoices are emailed monthly, and any past due amounts and late payment fees are due upon receipt. Any account 45 calendar days delinquent will be asked to promptly submit all outstanding payments and late payment fees.

Delinquencies over 60 calendar days may result in further consequences including, but not limited to, suspension or withdrawal from VNS. If you are unable to meet tuition obligations, you should reach out to the VNS Director or the Cornwall Presbyterian Church Pastor as soon as possible to discuss the possibility of a payment plan or apply for a tuition scholarship.

Late Pick Up Fee - After school care is not provided. Parents agree to be prompt and agree to pay a late pick-up fee of \$10.00 for every 15 minutes a student is left beyond the pick-up time. For example, a student left for 30 minutes past the end of the class would result in a \$20.00 charge on your account. The late pick-up fee will be billed monthly.

Withdrawal - The enrollment of your child at Village Nursery School is a ten-month commitment (September-June) that the Village Nursery School relies on to budget and plan for the school year. In the event where withdrawal before June 2024 is necessary, a 30-day written notice is required. No tuition will be refunded for the month of withdrawal. Any past due amount and late payment fees on your account must be paid in full. No other refunds will be given for services rendered.

Modification Conditions/ COVID-19 Planning

- 1. Village Nursery School reserves the right to modify any of the conditions of this agreement. A 30-day prior written notice will be given to the parent or legal guardian with any modifications to this agreement.
- 2. If a parent or legal guardian needs financial assistance, please contact the VNS Director or the Cornwall Presbyterian Church Pastor as soon as possible to discuss the possibility of a payment plan or a apply for a tuition scholarship.
- 3. As we continue to follow guidance and direction from the Centers for Disease Control and Prevention due to the COVID-19 pandemic, parents understand that if New York State schools are mandated to close, make-up dates for missed classes will be provided and, if necessary, additional days will be added to the school calendar in June 2025.
